The following proposal is being considered: Starting in 2014, employees will contribute \$600 a year toward their annual premiums and within a certain amount of years, full-time employees will pay a certain % of their annual insurance premiums. This proposal was tabled until the next meeting.

TRUSTEES COMPENSATION:

Amy Lewis moved to pay the Trustees and Fiscal Officer according to the statute (ORC 505.24 and 507.09) and the cost of living increases altered by the General Assembly in 2000. Based upon this and a 2014 annual budget of less than \$3,500,000, Trustees will be compensated \$11,318.00 and the Fiscal Officer \$19,806.00. Susan Spradlin seconded the motion.
