Chair Scott Miller called the meeting to order at 5:02 p.m. This was a work session advertised on the Xenia Township website within 24 hours of scheduling the meeting.

It was explained to the resident that the trustees could not make the speed limit change, but that this request would need to go through the County Engineer's Office.
