He said we have received a very large grant that is in process with the Ohio Public Works Commission and we will shortly be entering into an agreement with an engineering firm concerning that project. Mr. Miller explained what the agreement entails and what the crew will be doing and that letters will be sent out shortly letting those residents know when it will happen. Mrs. Spradlin said that there were a few questions they had and wanted to get a little more detail. She wanted to make it aware to the public before the letters go out, that there will be surveyors out there in early January. She asked if they wanted to hold off on sending the letter until they make some changes. Mrs. Spradlin made a motion to approve the professional agreement between Xenia Township Trustees as owner and Jones-Warner Consultants Inc. as engineer for the basic service for a total fee of \$49,900.00 with maximum input amount to be no more than \$100,000.00 for this project on Washington Rd, Mr. Miller seconded.
