Jim Reed called the meeting to order at 8:10 am. All participated in the Pledge of Allegiance.

The purpose of today's special meeting was to discuss the zoning inspector's position vacancy due to the February 20, 2012 resignation of Zoning Inspector Rhonda Painter.

The Trustees discussed the need for a full-time or part-time zoning inspector in the future. They discussed hiring Leona Fletcher as a part-time Zoning Inspector until the position is advertised and filled. Leona asked several questions. Her hours will be 8:00 to 11:30 a.m. Monday through Friday beginning February 13, 2012. She will be paid \$20.00 per hour. She will take care of zoning issues, answer phones and answer questions from residents. No insurance will be provided. She will be considered an employee of Xenia Township and not a sub-contractor. She will not attend Zoning Commission or Board of Zoning Appeals meetings.

The Township will begin proceedings on a bond for her. The secretary will give her passwords for the computer and phone messages and will give her an office key.

Scott Miller made a motion to hire Leona Fletcher as part-time zoning inspector for Xenia Township until a replacement may be hired. Amy Lewis seconded. Roll call vote: Lewis-Aye; Miller-Aye; Reed-Aye. Motion passed 3-0.
