FIRE DEPARTMENT:

Chief Beegle had nothing new to report on the Safety Council Report

Chief Beegle reported on the EMS Safety grant that we were awarded in the amount of \$1,200.00. Down a little more than half of expected. Other FDs reporting similar reductions. City of Xenia received the same amount.

Chief Beegle informed the trustees of the PT Firefighters hitting benchmarks, 600 hours: Cory Schrier.

Chief Beegle discussed the Global Report of Fire Apparatus – the department maintains twelve pieces of apparatus. The reports review manpower versus availability and reviewed by number of staffing and usage; costs of maintenance. Trustee Miller would like a chart with current status of all apparatus at any given time.
