Mr. Combs moved to enter into Executive Session at 5:04 p.m. for R.C. 121.22 (G) (1) to consider the employment, dismissal, or compensation of a public employee. Mrs. Spradlin seconded the motion. Those included were all elected officials.

Mr. Combs advised they exit Executive Session at 6:07 p.m. and resumed the regular meeting.

Chair Steve Combs called the Regular Meeting to order at 6:10 p.m. All participated in the Pledge of Allegiance.

Mr. Stock updated the trustees on the response from legal for the \$865.20 lien on the Union Rd. property. Our thought was it should have gone under the bond, but prosecutor's office responded this was an insignificant amount of money to go for collection.

Mr. Stock updated the trustees that the Board of Election has approved and certified the petitions for three (3) trustee positions on the November ballot.
