The Xenia Township Joint Trustee and Zoning Boards held a meeting on September 30, 2025 at 6:00 p.m. at the Xenia Township Office, 8 Brush Row Road, Xenia, OH 45385; this meeting was advertised on the Xenia Township website within 24 hours of scheduling the meeting.

Scott Miller called the meeting to order at 6:00 PM.

The meeting began with a discussion of areas in the township that hotels and restaurants could be supported. It was stated that the challenge is sewer and water access. The group next looked at areas in the township that have water and or sewer access. The group suggested the Dayton-Xenia Road and Old US 35 corridor would be an area to look at for hotels and restaurants.

The group next discussed roads in the Township that need attention with the help from Miami Valley Regional Planning Commission:

- Path 68 S to Fairground Rd (Near 235)
- US 68 S Caesercreek TWP to Xenia TWP to City of Xenia
- US 35 WB to Walmart Bend
- Outerview school access PED
- Brush Row @ US 68 Turning Radius (Trucks)

- US 68 & Innovation Way (Career Center Safety Zones)
- Brush Row / Massie Creek bridge winding for Peds for bike path
- US 42 & Bickett turning radius/Bickett density
- US 42 & Stevenson (new homes) & Bickett Road access
- US 35 Nash/Federal
- US 35 to Fairground (Expo Center)
- SR 235/US 68 Roundabout Signage
