- The Fiscal Officer gave a handout from Plattenburg about the audit. It is finished and they sent everything to the State Auditor's office. They finished with a finding of \$976.41 which consists of Orchard Trust, Countywide Credit Union, and Ohio Police and Fire. Xenia Township is now auditable.

  to direct staff to look for avenues to sell this very broadly over the next 120 days
  according to ORC 505.10, and in the event the items cannot be sold the items be
  given to either a political subdivision or a non-profit organization. Seconded by Mrs.

  by a roll call vote of 3-0.
- A motion was made by Mrs. Lewis for Garrett Beam and Jason Evans to be transferred from Paid-On-Call to Part-Time classification with the Xenia Township Fire Department effective April 1, 2014 at rate of \$11.94 per hour.
