MINUTES OF THE XENIA TOWNSHIP TRUSTEES:

REGULAR MEETING APRIL 3, 2014 7:00 PM

Note: These minutes are a summary of the discussion and are not a word for word account of the discussions. The proceedings were electronically recorded. The meeting place was the Xenia Township Office, 8 Brush Row Road, Xenia, Ohio.

PRESENT: Scott Miller, Chairman; Amy Lewis, Trustee; Susan Spradlin, Trustee; Barbara Miller, Fiscal Officer; Alan Stock, Administrator.

Meeting was called to order at 7:20 p.m. and all participated in the Pledge of Allegiance. This was a Regular Trustees Meeting advertised on the Xenia Township website within 24 hours of scheduling this meeting.

FISCAL OFFICER/FINANCE:

Request for approval of bills as presented. Mrs. Spradlin had questions about repairs on the snow blowers. Deputy Chief Beegle answered them. Mr. Miller asked about payment of the Dayton Regional Hazmat bill—this is scheduled to be approved tonight. Mrs. Spradlin gave a summary about a lease contract for the Dickman Directory. Mrs. Lewis would like to check with Stephanie Hayden to see if this is still a binding contract. Mrs. Spradlin questioned if there had been an accident because of a bill for a light bulb and bracket for Engine 52--Deputy Chief Beegle there was no accident. A motion was made by Mr. Miller to approve the bills with the exception of the bill for the Dickman Directory as presented. Motion died for lack of a second. Barb Miller talked about the bills being late if not approved tonight. Deputy Chief Beegle will look at the bills for the Fire Department. Scott Miller said they will come back to this topic.

TOWNSHIP ADMINISTRATOR:

Mr. Stock read the proposed Enterprise Zone Agreement between Xenia Township, Greene County and BEF (Bob Evans Farms) Foods, Inc. Peter Williams, Greene County Department of Development, spoke about the BEF, Inc. plant expansion on Birch Road in Xenia Township. There was an unexpected closure of a plant in Texas in September, and BEF, Inc. had to increase capacity elsewhere and they chose Xenia, Ohio over Hillsdale, Michigan. There will be a 22 person expansion, \$6.1 million facility expansion, and about 60% increase in production of food product at that site. Next door to the plant is Rogasin Institute (a medical research lab) which specializes in research on diabetes. The Institute uses the hog organs since they are very similar to human organs. When BEF renovates they are going to include a lab specifically for Rogasin's testing. A motion was made by Mrs. Lewis to consent to the Agreement by and between the Board of Commissioners of Greene County, Ohio, and BEF Foods, Inc. for the purpose of establishing, expanding, renovating or occupying facilities and hiring new employees and preserving jobs within Enterprise Zone 128C in exchange for specified local tax incentives granted by Greene County, seconded by Mrs. Spradlin. Roll Call: Ayes: Mr. Miller, Mrs. Lewis and Mrs. Spradlin. Motion PASSED by a roll call vote of 3-0.

 There is a request for an Agricultural Easement on 300 acres for Parcel #D11000100020000900 located in Cedarville Township. Part of this parcel (4 acres) crosses the Xenia Township line. A motion was made by Mr. Miller to approve the request for Agricultural Easement for Parcel #D11000100020000900 of which approximately 4 acres falls in Xenia Township, seconded by Mrs. Lewis. - The Greene Soil and Water Conservation District gave a presentation at the Work Session. They are requesting a Memo of Understanding be signed by Xenia Township--the last agreement was 12 years ago. There is no cost to the Township for their service. A motion was made by Mrs. Lewis to approve a Memo of Understanding between Greene Soil and Water Conservation District and Xenia Township (marked Exhibit A), seconded by Mrs. Spradlin. Roll Call: Ayes: Mr. Miller, Mrs. Lewis and Mrs. Spradlin. Motion PASSED by a roll call of 3-0. RESOLUTION NO. 2014-077

RESOLUTION NO. 2014-079

- There has been a question about the proper fund to return the money after the \$10,000 sale of 1999/2000 Medic. When it was purchased, the money was taken out of two funds. David Graham, Greene County Auditor, advised putting it in the Fire fund as it was equipment used by the Fire Department. The Fiscal Officer would like to check with the State Auditor's office before doing the receipt for the money. This issue was tabled until the next meeting.
- Xenia Township applied for a \$100,000 LGIF grant for the Fire Department radio system upgrades. The grant request was done last year and the money received this year, and, because the money had to be expended prior to it, money had to be transferred until the grant was received. Now it is necessary to transfer the \$100,000 back into the original place. Mrs. Miller said the transfer was for \$150,000 so the Trustees need to decide what to do about the \$50,000. Chief Fox had already said he will be pay this back at a later date. A motion was made by Mr. Miller to transfer the \$100,000 LGIF money out of Fire back into the General Fund, seconded by Mrs. Lewis. Roll Call: Ayes: Mr. Miller, Mrs. Lewis and Mrs. Spradlin. Motion PASSED by a roll call of 3-0.
