Fiscal Officer Seiter reminded the zoning board members have the option to be true unpaid volunteers or to be processed through payroll. Meyers advised yes, but lower based on duties. Seiter referred back to prior discussion of differences between pay, duties and years of services and asked whey these three captains are paid different. Meyers advised the captain's positions are different due to certifications, i.e. Beegle is a paramedic. Meyers noted he would like to split the current pay categories also, like lieutenants and paramedics are currently the same.
