Mr. Stock updated the trustees on Plank Law, Kingwood Solar financial update. They are aware that we have spent more money on this lawsuit than originally anticipated. They have been asked to only do the bare minimum going forward.

Mr. Stock informed the trustees that Spectrum upgraded speed and decreased cost; this is their current rates not a contract.

Mr. Stock asked if there was any discussion of July Tax Budget that is due in the Auditor's office; it will be on the next meeting agenda for a vote.
