Chair Steve Combs called the Regular Meeting to order at 6:01 pm.

# **FIRE DEPT:**

Chief Beegle discussed that Emergency Reporting was purchased by ESO for EMS reporting. Xenia fire department uses ImageTrend; Chief was part of that transition; Xenia has used for six years. This system will be easier to integrate; cheaper than ESO. Chief would like to be up and running by November. We will have access to the old systems archived data.

Mr. Combs moved to accept the two (2) year contract for EMS Billing to ImageTrend for \$7,520.00 the first year which includes setup fees and \$6,000.00 the second year, with the FO creating the P.O. at the appropriate time from 2282.230.319.9999. # **Guests:**

Chris Barnett; Hope Taft; and Bill Scheiman representing Miami Valley Watershed Network presented their Economic Study that they had done. The study looked at 43 miles of the Miami river. The river spans 115 miles from Springfield to Cincinnati; and serves over 3 million people. This groups is passionate about the taking care of the river and its development. They worked with an Ohio State professor Brent Sohngen, developing a survey that asked the question – "Why do you they come to the river and what do they do when they are at the river." 24 volunteers manned 35 sites along the 43 miles of the river that they studied from Springfield to Oregonia. Some of the findings from the study are that \$14.9 million dollars of value are generated, with \$1.9 million in

the Xenia area alone. The average age of the visitor is 45; over 836,000 trips were taken and most areas visited are the bike path and were the river are located together. The group issued 10,000 surveys and had a 17% response rate.
