## ROAD DEPARTMENT:

Mr. Pile updated the trustees on the Water and Wastewater Advisory Committee report. Update on COVID-19 protocols, self-assessment, one person per truck, etc. Study of COVID-19 in waste water is being performed with EPA, Ohio dept. of Health, and various universities throughout the state, sampling waste water throughout the state. The city of Oakwood did a cost study of water and sewer of 66 jurisdictions; Greene County came out in the middle.

Mr. Pile updated the trustees on the Stevenson Rd. cemetery. We received a \$1,000 grant to be used for headstone markers. The Road department would like to build a memorial wall with the broken pieces, approximately 20-30. This will allow for the monument to grow as more headstone break.

Mr. Pile presented the trustees information on the Road departments request to replace vehicles. The Road department would like to replace three (3) vehicles by the end of this calendar year: Pick-up truck - \$40,200; "Roger's" truck - \$158,000 and the "Baby" dump truck - \$98,100. The sale of the Union Rd, property will cover the majority of the replacement. Mr. Stock and Mr. Pile will work with vendor and have more information at a later meeting once they have confirmed pricing, inventory and availability.

Mr. Stock presented a financial snapshot. The township is over in revenue approximately \$71,000.

Mr. Stock informed the trustees of the Chamber of Commerce meeting. The next Business after Hours meeting will be held at Pinecrest. Xenia is planning an Oktoberfest 10/9/21 at Shawnee Park and Airforce Band and Fireworks 7/2/21 downtown.

Mr. Stock presented the first draft of the July Tax Budget for the trustee's review. Their will be a more detailed presentation at the next meeting. Due to Covid-19 the Auditor's office is not requiring the complete package as in previous years.

Mr. Stock informed the trustees that the contractor that the township has used in previous years for nuisance mowing will not be available this year and that the township is looking for a new contractor. The contractor has to provide liability insurance and Worker's Compensation insurance. The township loss \$275.00 of revenue to the state for nuisance mowing. The trustees asked the administrator to contact the prosecutor's office and inquire if we can put a sign up on the Main St. property stating "State of Ohio owns it".

Mr. Stock asked the trustees if they were interested in having a Community Clean-up day; due to postponement of last year's event due to COVID-19. The governor's health mandates expire June 2, 2021. Due to the risk of COVID-19 and not having the ability to properly social distance the event will be postponed.
