# **RECORD OF PROCEEDINGS**

Mr. Combs moved to enter into Executive Session at 5:04 p.m. for R.C. 121.22 (G) (1) to consider the employment, dismissal, or compensation of a public employee. Mrs. Spradlin seconded the motion. Those included were all elected officials.
