RECORD OF PROCEEDINGS

MINUTES OF THE XENIA TOWNSHIP TRUSTEES:

REGULAR MEETING JUNE 16, 2021

6:00 P.M.

NOTE: These minutes are a summary of the discussion and are not a word for word account of the discussions. The proceedings were electronically recorded. The meeting was held at the Xenia Township Office, 8 Brush Row Road, Xenia, Ohio. This was a Regular Trustee Meeting advertised annually and on the Xenia Township website within 24 hours of scheduling this meeting.

Beginning in January, all Trustee Meetings will be held via Zoom with the invitation credentials on the website the day before.

Chair Steve Combs called the Regular Meeting to order at 6:10 p.m.

All participated in the Pledge of Allegiance.

ROLL CALL: Steve Combs, Trustee Chair; Scott Miller, Trustee; Susan Spradlin, Trustee; Jacqueline Robinson, Fiscal Officer.

In attendance: Alan Stock, Administrator; Chief Greg Beegle was remote accessed. Guests: Mr. and Mrs. Brian Secor, BZA Candidate.

ADMINISTRATOR:

Mr. Stock introduced Brian Secor, a candidate for BZA, and asked the trustees to make a motion to appoint Brian Secor to the open position on BZA filling the term until December 31, 2022. Mr. Secor moved to XTWP in September 2019. Previously served on BZA for sixteen (16) years in Roanoke, Indiana, and was very active in the community serving on several committees. Mr. Secor scored 100 on the BZA test, met with Ed Jacobson, BZA Chair who recommends the trustee appoint Mr. Secor.

Mr. Combs moved to appoint Brian Secor to the open position on BZA filling the term until December 31, 2022. Mrs. Spradlin seconded the motion. Roll Call: Mrs. Spradlin – aye, Mr. Combs – aye, Mr. Miller - aye. Motion PASSED by roll call of 3-0.

RESOLUTION NO. 2021-096

Mr. Stock presented a financial snapshot. Revenue received is over budget by \$95k, across all funds. Adjustments to insurance and salary account lines will be made as needed, due to salary increases.

Mr. Stock informed the trustees that he and Mr. Pile are researching availability of Road Department replacement vehicles.

Mr. Stock asked for any agenda items for the Combined Zoning Meeting on May 30, 2021. Current agenda includes, New Zoning Use and Size recommendations. The BZA has been working on this project for the past 2 years; the last change was in 2006.

Mr. Stock updated the trustees on the Quarterly JEDD meeting; XTWP will receive \$9,487.27 for the first half of the year, which is \$1.487.27 over budget. This JEDD is for the two parcels at Tecumseh school. Mr. Miller asked about the status of the CEDA — which Mr. Stock replied that is was delayed due to COVID-19 and that he will contact John Albers to get an updated status.

Mr. Stock asked the trustee to create a P.O. to iWorQ for \$4,600.00, 1/3 from each Department, 1000/110, 2031/330, 2282/230 with the same last digits 319-9999 respectively. This is for annual software maintenance, that is used for zoning, fire and road management of fleet maintenance. Mr. Miller would like to see a way to track incoming telephone calls, including who called, routed to, and response.

Mr. Stock informed the trustee's that the state legislature will vote next week to give Townships a portion of the last funding released.

Mr. Stock informed the trustee's that the River Ranger's spent \$48,000 to clear safe passages on the Little Miami River. It was discussed that maybe the other townships should start putting funds aside for future maintenance of the river.

Mr. Stock presented on the Chamber of Commerce meeting – no meeting for the next 2 months and the annual dinner has been postponed. There will be informational meeting on "what to do with Xenia Town Square" for residents input. Xenia will host a Block party on July 2, 2021 downtown, followed by music at Shawnee Park and ending the evening with the Sunnycalb firework show.

Mr. Stock updated the trustees on the nuisance mowing; still have not found a contractor, any recommendations are welcome. Township will rent Bush hog and Road department will mow. Mr. Stock presented two (2) properties for nuisance mowing.
