RECORD OF PROCEEDINGS

MINUTES OF THE REGULAR MEETING XENIA TOWNSHIP TRUSTEES: NOVEMBER 18, 2021 6:00 P.M.

NOTE: These minutes are a summary of the discussion and are not a word for word account of the discussions. The proceedings were electronically recorded. The meeting was held at the Xenia Township Office, 8 Brush Row Road, Xenia, Ohio. This was a Trustee Meeting advertised annually and on the Xenia Township website within 24 hours of scheduling this meeting.

Beginning in January, all Trustee Meetings will be offered to the public via Zoom with the invitation credentials on the website the day before. Zoom meetings are offered but quorum cannot be met by Zoom.

Chair Steve Combs called the Trustee Meeting to order at 6:00p.m. All participated in the Pledge of Allegiance.

FIRE DEPARTMENT:

Capt. Logan Surls did a presentation on a Fire Burn training evolution. This evolution was held October 9, 2021. Property located on Dayton-Xenia Rd., donated by Martin Marietta; Lowes and River Metal Recycling also donated supplies. Training evolutions included search and rescue; building stabilization; and basement/2nd floor training. There were approximately 30 participants, 15-hour day; Capt. Surls thanked Tony Albertini for stepping up and helping with the documentation. There is a possibility of another vacant house on Jacoby Rd. being donated for fire and rescue training.

Chief Beegle, discussed the Damage to apparatus assessment that his department has been doing. Safety has to be at the forefront of the departmental goals; Trustee Miller suggested using after action review; what happened, what could be done different should be part of the review; Trustee Combs mentioned that he is not in favor of back-end discipline. Chief mentioned that there are newer people in the department; there are vehicle checklists with a written and verbal test; also, skills tests. The department has 4 EVOC Instructors and they are and have identified which employees need additional skills training and they have developed an annual training schedule. The department has identified areas of township roads that may have nuisances to them and these are noted.

Trustee Spradlin expressed deep sadness and condolences on the passing of Sheriff Gene Fischer. Sheriff Fischer was a township resident. The township has ordered two Banners; one for each station.
