NOTE: These minutes are a summary of the discussion and are not a word for word account of the discussions. The proceedings were electronically recorded. The meeting was held at the Xenia Township Office, 8 Brush Row Road, Xenia, Ohio. This was a Regular Trustee Meeting advertised annually and on the Xenia Township website within 24 hours of scheduling this meeting.

Beginning in January, all Trustee Meetings will be offered to the public via Zoom with the invitation credentials on the website the day before. Zoom meetings will be offered but quorum can not be met by Zoom.

Chair Steve Combs called the Regular Meeting to order at 6:00 pm.

All participated in the Pledge of Allegiance.

Guests: Lauren Gjessing, Tecumseh Land Trust, Major Shawn Prall and Sheriff Scott Anger of Greene County Sheriff's Office, Pastor Will Urschell, Xenia City Council member.

Ms. Lauren Gjessing, of Tecumseh Land Trust spoke to the trustees about their request to the State of Ohio. They are asking the trustees for a resolution for support of their application to the State of Ohio for purchase of an agricultural easement on 51.3 acres owned by Katherine and Karl Finkes located on Winchester Road, parcel number M36000200350003200. The township will work with the city and ODOT prior to the project on US 68 South is finished. Tecumseh Land Trust can work with ODOT on the easement in the right of way and for additional expansion, but the easement will not take of the situation. Ms. Gjessing has an updated resolution for the township. Mr. Miller and Combs have asked Ms. Gjessing to work with her bosses of the past history with the township concerning the annexation and 68S, and would appreciate to be informed of anything that will affects the township in the future.
