This was a Regular Trustee Meeting advertised annually and on the Xenia Township website within 24 hours of scheduling this meeting.

Beginning in January, all Trustee Meetings will be offered to the public via Zoom with the invitation credentials on the website the day before. Zoom meetings will be offered but quorum can not be met by Zoom.

Chair Steve Combs called the Regular Meeting to order at 6:05pm.

FISCAL OFFICER:

FIRE DEPT:

Mr. Stock asked the trustees to create a P.O. to Phoenix for safety turn-out gear (8 sets) of \$23,200.00 from 2111-760-740-1201. If so approved, \$1,700.00 would be transferred from 2111-760-740-1202, Machinery and Equipment Fire Equipment, into this account for the P.O.

RESOLUTION NO. 2022-068

Mr. Stock asked the trustees to accept the resignation of PT FF Justin Comer effective immediately. Mr. Comer would be eligible for re-hire. Mr. Comer has a full-time position that pays overtime for his paramedic training.

Mr. Miller moved to accept the resignation of PT FF Justin Comer effective immediately. Mr. Comer is eligible for rehire. Mr. Miller seconded the motion. Roll Call: Mr. Combsaye, Mr. Miller – aye, Mr. VanDyne - aye. Motion PASSED by roll call of 3-0.

RESOLUTION NO. 2022-069

Mr. Stock announced that the fire department was awarded safety grant of \$ 848.12 from the state; to cover class reimbursements.

Mr. Stock informed the trustees that the FD is participating in the annual Road Race on Sunday, April 03, 2022.

On March 9, 2022 at 3:26pm the Medic 51 was on the scene of a township residence with chest pains. They spent 45 minutes on the scene; Chief Beegle presented a commendation for Joe Mullikin, Cody Dotson, and Jessica Williams.

TOWNSHIP ADMINISTRATOR:

Mr. Stock informed the trustees that Jessica Williams has been approved for $\frac{1}{2}$ tuition for Fire Officer 2 class from the FD training budget.

Mr. Stock discussed the vacant lot, 50 Arthur Dr. and taking possession with fees. The lot is owned by an Investment Group; back taxes are \$7,506.55. The township has not mowed the lot or incurred any other costs. This discussion is on hold for now.

Mr. Stock clarified the proposal of selling of 1333 E Main St. The proposal excludes survey work and an auctioneer; requesting sealed bids in two weeks. The lots cannot be improved upon unless combined and zoned as residential. The highest and best bid will be awarded.

Mr. Stock presented the financial snapshot of the township; currently \$33,000 over in expected Revenue.

Mr. Stock asked for any new agenda for the Combined ZC/Trustee Boards. The last meeting was November 30, 2021; next meeting is March 29, 2022 at 6pm. Route 68 S is on the agenda

TRUSTEES' BUSINESS:

Mr. Combs provided updates Kingwood Solar lawsuit. Mr. Combs spent three days in hearings providing testimony. Kingwood will subpoena 2 additional witnesses and there are 6 rebuttal witness. The next meeting is April 25, 2022.

Mr. VanDyne provided updates on the Health District Advisory Committee – The health department is paying off the building \$5.5million to build; COVID funding is halting; there are no mask mandates in the county.

Trustee VanDayne asked the township administrator to provide a list of the ARPA requests with the proposed amount of funding for each project.

Trustee Miller provided information on the Trade Show FDIC International, April 25-30, 2022 in Indianapolis, IN. Mr. Stock will ask the fire department if there is anyone who would like to attend.

Trustee Miller provided updates from the MVRPC meeting – topic of discussion was "Why Not"; why not buy an electric car; auto industry is going 100% electric by 2032; most homes will not be able to support an electric charging station. Trustee Miller and Trustee VanDyne are on committee for Miami Valley Regional Planning Commission.

Trustee meeting Tuesday, April 19, 2022 will be held at 125 Fairground Rd.

Mr. Miller moved to adjourn at 8:18pm. Mr. Combs seconded the motion. Roll Call: Mr. Combs – aye, Mr. Miller – absent, Mr. VanDyne – aye. Motion **PASSED** by roll call of 3-0.
